UN Police Division, UNODC, UNDP, OHCHR, and UN Women Over 80 participants attended the First Meeting of the High-Level Network on Gender-Responsive Policing in person at the UN Secretariat and a further 30 Network Members and gender-responsive policing experts joined online, including from their respective capitals.

Brazil, Finland, France, Iceland, Norway, Peru, and Spain presented on examples of 'good practice' from their respective countries, in addition to challenges and lessons learned. These included establishing multi-sectoral support centres for survivors of sexual and gender-based violence and specialized police patrols, increasing women's representation and visibility in the police force, streamlined case reporting and increasing public awareness and training.

Challenges included resistance to changing police culture, which takes time, as well as resources constraints and addressing perpetrator accountability.

Network Members expressed their strong commitment to gender-responsive policing, including strengthening institutions, preventing and responding to sexual and gender-based violence and ensuring perpetrator accountability. They also called upon other Member States to consider joining this important initiative.
